PE “Roads of Serbia” – the Employer has applied for the funds from the European Investment Bank – EIB (hereinafter referred to as “the Bank”) – towards the cost of the Consultancy Services for Supervision of Lot B3.2.

The Employer hereby invites consulting firms and consortia to submit tenders for the following contract to be funded from parts of the proceeds of the European Investment Bank Loan, Belgrade By-pass Project, based on article 7, paragraph 1, item 2, sub-item (2) of Public procurement Law (“Official Gazette RS” no.124/12) and published tender documents:

Consulting Services for the Supervision of Lot B3.2 - Construction of Bridge No.8 Over Sava River Near Ostruznica.

This contract is expected to be implemented from December 2015 to February 2018.

The selection of the Consultant will be based on the Quality and Cost Evaluation.
