INVITATION FOR TENDERS

LOT 8 Design and Construction of the "Nova Pazova" Interchange

The Public Enterprise "Roads of Serbia", hereinafter referred to as "the Employer", intends using part of the proceeds of a loan from the European Bank for Reconstruction and Development (the Bank) towards the cost of LOT 8, of the Belgrade Highway and Bypass Project.

The Employer now invites sealed tenders from contractors for the single contract to be funded with the proceeds of a loan. Therefore, based on article 7, paragraph 1, item 2, sub-item (2) of Public procurement Law ("Official Gazette RS" no.124/12) for selection of the successful tenderer the Bank special procurement procedures will be applied.

The Contractor is expected to prepare Design for Construction Permit approved by the Technical Committee as required by the Law of Republic of Serbia, Excerpt of Design for Construction Permit and Design for Execution of Works and to execute all works defined by the approved and accepted Design Documents for construction of the "Nova Pazova" Interchange.

The works will consist of (but shall not be limited to) the following:

- Works on road area which include Preliminary Works (removal of excessive vegetative material and waste, demolition and milling of the existing pavement, relocation of wire fence and protection of TC cables), Earth Works (excavation of top soil, embankment construction and topsoiling), Pavement Works (construction of: sub-base layers from mechanically stabilized crushed stone aggregate, bituminous base course, asphalt concrete wearing course and concrete curbs) and Drainage Works (ditch excavation);
- Works on drainage which include Earth Works (excavation and planning for laying pipes and gullies, backfilling with sand and gravel and loading and overhauling of excavated earth material), Carpentry Works (trench shoring), Fitting Works (supply, transport and placing of PVC sewer pipes, gullies and gratings), Concrete and reinforced concrete Works for relaying gratings and watertightness testing of pipeline;
- Works on structures which include Bridge in the Motorway base (removal of curbs, fence, cornice, pedestrian footpath and part of slab; excavation of foundations; concrete works on piles, part of slab, cross beam, pedestrian footpath; assembling of prefabricated beam; placing of reinforcement and steel protective fence, curbs, cornice and plastic pipes in pedestrian footpath; coating of concrete surfaces by protective layer; construction of asphalt concrete wearing course) and Overpass (removal of curbs, fence and asphalt concrete wearing course; excavation of trenches and channels; concrete works on pedestrian footpath and slope round head foundation, lining of the slope round heads by concrete

slabs; placing of reinforcement, steel protective fence and expansion joints on the pedestrian footpaths, curbs, gutters and plastic pipes in pedestrian footpath; coating of concrete surfaces by protective layer);

- Works on traffic signs and road furniture which include road marking and roadside arrangement and placement of traffic signalization and road furniture;
- Works on public lighting which include supply of main material and construction of public lighting with public lighting cabinet;
- Works on landscaping which include protection of slopes and embankments in accordance with the designed solution;

The Works will be performed <u>under traffic</u> with a strong emphasis on maintaining safe conditions for both the flow of traffic and the works in progress.

Time for completion of Works is 240 calendar days.

Tendering for contracts to be financed with the proceeds of a loan from the Bank is open to firms from any country. The proceeds of the Bank's loan will not be used for the purpose of any payment to persons or entities, of for any import of goods, if such payment or import is prohibited by a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations.

To be qualified for the award of a contract, tenderers must satisfy the following requirements:

Financial requirements

- Submission of audited balance sheets or if not required by the law of the Tenderer's country, other financial statements acceptable to the Employer, for the last **three (3)** years to demonstrate the current soundness of the Tenderers financial position and its prospective long term profitability;
- Minimum average annual turnover of EUR 4,000,000 (four million EUR) equivalent, calculated as total certified payments received for contracts in progress or completed, within the last three (3) years;
- The Tenderer must demonstrate access to, or availability of, financial resources such as liquid assets, unencumbered real assets, lines of credit, and other financial means, other than any contractual advance payments to meet: (i) the following cash-flow requirement: min. EUR 1,200,000 (one million two hundred thousand EUR) equivalent, and (ii) the overall cash flow requirements for this contract and its concurrent commitments.

Experience requirements

- General experience Experience under contracts in the role of contractor or management contractor for the last five (5) years prior to the tender submission deadline, and with activity in at least nine (9) months in each year.
- Specific experience:
 - (a) Relevant experience as sole contractor or partner in JVCA in at least two (2) contract motorway or semi-motorway or double carriage road with asphalt concrete pavement or motorway interchange construction / reconstruction / rehabilitation that is completed after 1st January 2011, where minimum value of the contractor's share per contract must be at least EUR 2.0 mill. (two million EUR);
 - (b) For the above or other contracts executed during the period stipulated in (a) above, a minimum experience in the following key activities: 10,000 tons of asphalt mixtures (BNS and AB) at least in one month placed in road paving.

Above and all other qualification requirements related to the eligibility, litigation history, and technical capabilities are specified in the Section III. Evaluation and Qualification Criteria of the Tender Documents.
