Pursuant to Article 26. paragraph 1. of the Law on Public Enterprises ("Official Gazette RS" no: 15/16) and Article 42, paragraph 1 of the Statute (ref. no. 953-1833/15 dated 26.01.2016) and following the conducted procedure for Contract award for procurement to be funded with the proceeds of a loan from the European Investment Bank, according to article 7. paragraph 1. item 2) sub-item (3) of Public Procurement Law ("Official Gazette RS" no.124/12, 14/15 and 68/15) and published tender documents and based on the report of the Committee responsible for conducting of the procurement procedure in subject, I hereby make the following

DECISION

The Bid no: **404-140/17-8** dated 26 July 2017 from **"MBA-RATKO MITROVIĆ NISKOGRADNJA" d.o.o.**, Savski nasip 1-3, 11070 Novi Beograd, Republic of Serbia is selected as the most favourable for conclusion of Contract for works procurement – **Construction of Remaining Works, Sector B5.3 – Construction of "Petlovo Brdo" Interchange and "Orlovaca" Interchange – Final Solution** in total amount of **497,867,905.37 RSD without VAT** (or 597,441,486.44 RSD, VAT included).

Explanation

On May 19, 2015 the Employer made a Decision no: 404-156/15-1 about initiating of works procurement procedure for **Construction of Remaining Works, Sector B5.3 – Construction of "Petlovo Brdo" Interchange and "Orlovaca" Interchange – Final Solution**.

For the aforementioned procurement the Employer has announced Invitation for Tenderers for obtaining of Bids on Public Enterprise "Roads of Serbia" web site on 08.06.2017, in the daily newspapers "Politika" dated 8 June 2017 issue for the whole country and in the Official Gazette of the Republic of Serbia no. 57 dated 09 June 2017.

In due time the Employer received six bids with one modification to bid. The procedure of public opening is conducted in the premises of the PE "Roads of Serbia" on 26 July 2017. The minutes of meeting from the public opening of bids is registered under ref no: 404-140/17-12.

Following expert evaluation of the bids and in compliance with the prescribed evaluation procedure (the Contract is awarded to the Tenderer who submitted complete, correct and substantially responsive bid with the lowest evaluation price that meets the set qualification criteria), the Committee made a final report on 8 September 2017, while the *"no objection"* to the report from the European Investment Bank is issued on 24 November 2017. Within the report the following is determined:

1. Subject to procurement are the works on Construction of Remaining Works, Sector B5.3 – Construction of "Petlovo Brdo" Interchange and "Orlovaca" Interchange – Final Solution, financed from the loan by the European Investment Bank, which estimated value within the Business Plan is 366,500,000.00 RSD.
2. All six bids are evaluated as complete, correct and substantially responsive to the Tender Documents requirements, thus for these six bids evaluation price of bid is determined and qualification verification is carried out:

3. Substantially responsive and complete bid with the lowest evaluation price is the bid submitted by MBA-RATKO MITROVIĆ NISKOGRADNJA D.O.O., that meet all qualification criteria, thus, this Bid may be selected as the most successful.

4. The Bid no: 404-140/17-8 dated 26 July 2017 from Tenderer "MBA-RATKO MITROVIĆ NISKOGRADNJA" d.o.o., Savski nasip 1-3, 11070 Novi Beograd, Republic of Serbia, is complete, correct and substantially responsive bid with the lowest evaluation price that meets the set qualification criteria, thus, in compliance with Article 34 Instructions to Tenderers and following the approval from the European Investment Bank it is decided as said in the Disposition.

Pursuant to this Decision, procurement Contract shall be signed which will closely arrange the mutual rights and obligations between PE "Roads of Serbia" and the selected Contractor.

The Decision for selection of the most favourable Contractor shall be delivered to all Tenderers who submitted Bid.

INSTRUCTION ON LEGAL REMEDY:

The Tenderer may against this Decision, in accordance with the Government's conclusion 05 No: 48-11916/2017 dated December 05, 2017, file a Request for protection of rights pursuant to the Provisions of Article 149. and Article 151. of Public Procurement Law ("Official Gazette RS" no.124/2012, 14/2015 and 68/2015).
