INVITATION FOR TENDERS (IFT)

HEAVY MAINTENANCE (UPGRADING) OF THE STATE ROAD IIA 160 SECTION: SVILAJNAC (CRKVENAC) - MEDVEĐA (GLOGOVAC) FROM KM 44+057 TO KM 58+860 L=14.803 KM

- 1. The Republic of Serbia has received financing from the European Investment Bank (EIB) toward the cost of the Road Rehabilitation Project, and intends to apply part of the proceeds toward payments under the contract for Heavy Maintenance (Upgrading) of the State Road IIA 160, Section: Svilajnac (Crkvenac) Medveđa (Glogovac), from km 44+057 to km 58+860, L=14.803 km, Contract ID No. RRSP/RRW-IIA160SM/2019-12. The General Conditions of Contract shall be the "Conditions of Contract for Construction for building and engineering works designed by the employer", 1st edition 1999, prepared by the Fédération Internationale des Ingénieurs-Conseils (FIDIC). This contract will be jointly financed by the European Investment Bank and Republic of Serbia. Tendering process will be governed by the EIB's rules and procedures.
- 2. The Public Enterprise "Roads of Serbia" (hereinafter referred to the Employer) invites sealed tenders from eligible and qualified tenderers for heavy maintenance (upgrading) works consisting of the following:
 - Preliminary works which include removal of excessive vegetative material, demolition of existing road elements (curbs, pavement, concrete elements...), demolition and removal of elements of the damaged constructions and surface preparation of the existing pavement for application of new layers (milling of the existing pavement, repair of damage to the existing pavement);
 - Substructure works which include excavation, subsoil treatment, construction of embankment, shoulders and berms, topsoiling;
 - Improvement of drainage system works which include works on drainage system surface drainage, construction of drainage ditches, subsurface dewatering-drainage, closed drainage system, making shafts, hydro technical works (procurement, transportation and installation of drainage pipes and bypass separators);
 - Superstructure works which include pavement construction on intersections, access and pedestrian roads; works on improvement of pavement (construction of unbound, bituminous base course, and construction of wearing asphalt concrete course), as well as placement of concrete curbs and construction of gutters;
 - Works on structures (culverts and retaining wall) which include works on existing box, pipe and arched culverts, replacement of dilapidated culverts

with new, cleaning, excavation, extension on widening, concrete and stone works, construction of new slabs over existing, repair or replacement of the footpaths and waterproofing, repair of fences and guardrails and other repair works. Works on the retaining walls include construction of new walls height 0.8-1m;

- Roadside arrangement and placement of traffic signalization and road furniture;
- Works on repairing and replacing the elements of the upper part of the railway track and the road on intersects with the railway at the road crossing in two points: at km 47+545.48 and at km 55+616.81;
- Works on landslide remediation.

The Works will be performed under traffic with a strong emphasis on maintaining safe conditions for both the flow of traffic and works in progress.

The construction period is 15 months.

The Tenderer should meet the following qualification criteria and capabilities:

Financial requirements

- Submission of audited balance sheets or, if not required by the law of the Tenderer's country, other financial statements acceptable to the Employer, for the last 5 (five) years to demonstrate the current soundness of the Tenderers financial position and its prospective long term profitability. In the case of JV, each partner must meet the requirement.
- Minimum average annual construction turnover of 1,100,000,000 (one billion one hundred million) RSD equivalent, calculated as total certified payments received for contracts in progress or completed, within the last 5 (five) years. In the case of JV, all partners combined must meet the requirement, the lead partner must meet 60% (sixty percent) of the requirement and each other partner must meet 30% (thirty percent) of the requirement.
- The Tenderer must demonstrate access to, or availability of, financial resources such as liquid assets, unencumbered real assets, lines of credit, and other financial means, other than any contractual advance payments to meet the following cash-flow requirement: min. 225,000,000 (two hundred twenty-five million) RSD equivalent. In the case of JV, all partners combined must meet requirement, the lead partner must meet 60% (sixty percent) of the requirement and each other partner must meet 30% (thirty percent) of the requirement.

Experience requirements

- General experience Experience under contracts in the role of contractor or management contractor for the last 5 (five) years prior to the tender submission deadline, and with activity in at least 9 (nine) months in each year. In the case of JV, each partner must meet the requirement.
- Specific experience:
 - Participation as contractor or management contractor in at least 2 (two) contracts, within last 5 (five) years, each with a value of at least 540,000,000 (five hundred forty million) RSD equivalent that have been successfully and substantially completed and that are similar to

- the proposed Works. In the case of JV, all partners combined must meet the requirement, the lead partner must meet the requirement for at least 1 contract out of 2.
- For the above or other contracts executed during the stipulated period, a minimum experience in the following key activities: production and laying of asphalt mixtures (asphalt concrete and bituminous base) not less than 30,000 tones/year in the last 3 (three) years calculated as average during the specified period. In the case of JV, all partners combined must meet the requirement.

Above and all other qualification requirements related to the eligibility, litigation history, and technical capabilities are specified in the Section III Evaluation and Qualification Criteria of the Tender Documents.

- 3. Tendering will be conducted through the International Procurement Open Procedures specified in accordance with "Guide to Procurement for projects financed by the EIB" issued in September 2018 ("Procurement Guidelines") available at the following link: https://www.eib.org/en/publications/guide-to-procurement. Tendering is open to all eligible tenderers as defined in the Procurement Guidelines. In addition, please refer to paragraph 1.5 setting forth the Bank's policy on conflict of interest.
